River Forest District 90 Committee of the Whole and Board of Education Organizational Meeting Highlights May 6, 2013

COMMITTEE OF THE WHOLE MEETING

The meeting was called to order at 7:00 p.m. All members were present.

Official Canvass of Non-Partisan Election of April 9, 2013

The results of the April 9, 2013, election were canvassed by the Cook County Board of Elections, declaring the results of the election verified and received by the District. Elected to be a member of the Board for a full term of four years were Roman Ebert, David Latham, Patrick Meyer, and Anne Gottlieb. Adopted as presented.

Education Committee, David Latham, Chair

1. Advanced Differentiated Learning (ADL)

The presentation was delivered by Director of Student Services Martha Ryan-Toye, teachers Louisa Starr and Lynn Voss, Roosevelt Principal Larry Garstki and Superintendent Ed Condon.

Over the course of the last year, the Superintendent's Leadership Council (SLC) has reviewed the manner in which the needs of gifted and talented students are met in District 90. The process involved identifying strengths and weaknesses of current instructional practices and programming, as well as an examination of "best practices" in serving gifted/talented students. The SLC also determined that the contemporary term "Advanced Differentiated Learning" would be used in District 90 to describe gifted and talented instruction. Finally, the

SLC established three subcommittees to review the District's programming options in more detail. These subcommittees included "Instructional Differentiation," "ATP Programming," and "Supports and Services for ADL Students." After thorough investigation in each of these areas, the subcommittees reported their recommendations to the SLC for review. After refinement, the final SLC recommendations were prepared for the Board of Education's consideration.

Committee Findings/Recommendationis

- Hire an Instructional Specialist for each school to provide collaborative leadership in the areas of differentiation and curriculum development (three total).
- Provide appropriate professional developments for faculty and staff, over time, regarding the needs of advanced learners.
- Adopt revised ATP identification matrices and parent communication protocols.
- Provide ongoing review of the ATP curriculum to ensure adequate rigor, in context with Common Core.
- Maintain the accelerated math program in the current configuration at the elementary level.
- Increase support for academically focused extra-curricular clubs and activities.
- Increase opportunities for students to participate in outside gifted and talented programming (such as the Midwest Academic Talent Search, etc.).
- Explore avenues to provide ADL students with additional support in areas of socialemotional development.

Finally, the presentation emphasized the need for deliberate and regular program evaluation to determine ongoing effectiveness. Using data, performance targets will be established for this purpose moving forward.

Juli Geldner thanked the committee members for their work.

Communications Committee, Juli Geldner, Chair

1. Educational Foundation: Background about educational foundations was presented by Ms. Geldner. She reported that approximately \$18,500 has been contributed on behalf of District 90 over the years, which is being held on account by the Oak Park/River Forest Community Foundation. Consideration of the establishment of a foundation may be added to the Board retreat agenda.

Staff Appreciation from the Board of Education

Mrs. Fischer suggested that the Board determine a small but meaningful way to recognize the significant contributions of the staff this year. Various comments were shared.

Resolution of Appreciation for JuliAnn Geldner

Mr. Weiss presented a resolution in recognition of JuliAnn Geldner's contributions to the Board of Education and District 90. Approved.
